Official Notification Federal Boat Safety Act Over Torque of Flywheel Bolt - 20/25 (2-Stroke) & 20 Jet

Models Affected

MERCURY/MARINER

1998 20/25 (2-Stroke) & 20 Jet

USA S/N 0G683156 thru 0G686362 Belgium Production is NOT affected.

The outboards listed, may have been assembled with a torque level on the flywheel bolt that is too high. The higher torque was caused by a plating change (gold in color changed to gray) on the washer under the flywheel bolt, which reduced the friction under the bolt head. The flywheel bolt could have been over stressed which can cause a fracture, resulting in the possible loss of the flywheel. These units **MUST HAVE** both the flywheel bolt and washer replaced prior to operation.

Owner Notification

A letter will be sent to every registered owner of an affected outboard. The letter will advise the owner to return their outboard to their selling dealer or any authorized dealer for replacement of the flywheel bolt and washer. A copy of the letter is included with this Service Bulletin.

Repair Identification

Outboards within the serial number range listed that have been reworked at the factory are identified by:

 A blue dot sticker applied on the outboard serial number label of the shipping carton

Dealer Outboard Inventory

Affected outboards in dealer inventory **MUST BE** re-worked prior to customer delivery. Outboards within the listed serial number range that have a gold colored washer do not require repair. Outboards outside this serial number range are not in need of repair regardless of washer color.

Service Parts Stock

Flywheel washers (P/N 12-86496) may be of mixed stock (Gold or Gray) and both are serviceable when the flywheel bolt is torqued to the new specification of 50 lb. ft. (67.8 N·m).


NOTE: Please mark flywheel bolt torque change where listed in the outboard service manual. New flywheel bolt torque is to be used with either washer.

Correction

IMPORTANT: Refer to outboard service manual for proper flywheel bolt replacement procedures.

- 1. Remove manual starter. Remove and discard flywheel bolt and washer.
- 2. Secure flywheel using new flywheel bolt/new washer. Torque bolt to 50 lb. ft. (67.8 N·m).
- 3. Re-Install manual starter. Apply Loctite 222 (p/n 92-809818) to threads of (3) mounting bolts and torque bolts to 110 lb. in. (12.4 N·m).

Dear Customer:

Our records indicate that you are the owner of an outboard engine included in a recall being conducted in accordance with the Federal Boat Safety Act. The flywheel bolt could break and allow the flywheel to separate from the engine while revolving at high speed. This is a hazardous situation that must be taken care of before you again operate your engine.

DO NOT OPERTATE YOUR ENGINE UNTIL THESE REPAIRS ARE DONE

NOTE: If your boat currently is in storage, it is permissible to have the repairs performed when the boat is removed from storage. The repairs <u>must</u> be completed before you use the engine again.

WHAT YOU SHOULD DO

Contact your authorized dealer, preferably the one who sold you the engine, and make arrangements to deliver your engine to the dealer to have the necessary repairs performed. The reverse side of this letter is a pre-printed recall claim form covering the service.

WHAT WE WILL DO

The dealer will perform the repairs at no charge to you. We will reimburse the dealer upon receipt of the claim form.

Please make arrangements to have this work done as soon as possible. We apologize for inconveniencing you but we are taking action in the interest of your safety and satisfaction.
