Situation

A quantity of Quicksilver branded oil filter bulk packs (p/n 35-877761Q01) have been shipped with the incorrect box point of sale package (p/n 35-866340Q03) for the filter. The filter within the box point of sale package matches the bulk pack part number and is labeled correctly on the filter body. The bulk packs in question are stamped with the date code 052810 and should be inspected prior to use.

Correction

Inspect the box point of sale packages within Quicksilver branded oil filter bulk packs (p/n 35-877761Q01) which have a date code of 052810.
