Velvet Drive[™] Marine Gear Distributors (USA and International)

Velvet Drive[™] has a distribution program to provide service for its marine customers. Velvet Drive's distributor and dealership organizations also provide normal rebuilding, repair service, and parts. Contact the Velvet Drive distributor in your area for details on obtaining parts and service or on becoming a Velvet Drive dealer for transmission sales, service, and processing of warranty issues.

If the product requires repair under warranty, consult Mercury MerCruiser Technical Service before removing the transmission. They will give directions to either replace the transmission or proceed with sending the transmission to a Velvet Drive distributor or dealer.

After receiving pre-authorization, deliver the transmission or ship it, freight prepaid, for repair to the Velvet Drive distributor or dealer. These guidelines also apply to units that are covered under the Mercury Product Protection plan. Submit pre-authorized warranty claims through the normal warranty processing channels for reimbursement.
