MerCruiser MPI Engines Now Equipped With Low-Permeation Fuel Lines

Models Affected

MPI Engines with the serial numbers listed are produced with low-permeation fuel lines.

Situation

All MerCruiser MPI engines produced after January 1, 2009 are required to have low-permeation flexible fuel lines on the high-pressure side of the fuel system (after the Cool Fuel pump). The flow and pulse characteristics of the low-permeation fuel lines are different from the standard fuel lines and require specific Engine Control Module (ECM) and Propulsion Control Module (PCM) calibrations matched to the new lines. Engines must be kept as originally built. Do not mix the application of the low-permeation fuel lines or the associated ECM or PCM with that of the standard fuel lines or the associated ECM or PCM.

No performance advantage is gained by replacing the standard fuel lines and the associated ECM and PCM calibrations with low-permeation fuel lines and the associated ECM and PCM calibrations. Converting an engine equipped with low-permeation fuel lines and controller calibrations to standard fuel lines and controller calibrations is prohibited.


Ordering Parts
