# Replacement Distributor Cap on MerCruiser MPI Engines With HVS Ignition Systems


# Scope

Worldwide

# Models Affected

Models Covered	Serial Numbers
All MerCruiser V8 engines with HVS ignition systems	0M300000 and above

**NOTE:** Only replacement distributor caps or distributor cap and rotor kits with box dates (as identified on the box) between **January 1, 2011, and May 24, 2011**, that have **brass conductors** are affected by this bulletin. Distributor caps with date codes outside of the abovementioned dates are unaffected by this bulletin, regardless of conductor type.



- a Good: Distributor caps with aluminum conductor (silver color)
- Needs to be replaced: Distributor caps with brass conductor (gold color) and box dates between January 1, 2011, and May 24, 2011, only.

# Situation

MerCruiser has received reports of a misfire condition occuring after recent installation of service replacement distributor caps that have brass conductors. The misfire typically begins to occur after 20 minutes of engine operation.

# Correction

For parts already installed: Replace the part and file a warranty claim for parts and labor (see Warranty below).

For parts not installed but in dealer inventory: If the box date code is between January 1, 2011, and May 24, 2011, and the distributor cap uses brass conductors, file a warranty claim for parts only.

#### **Owner Notification**

Dealers are asked to notify consumers who have had the service replacement distributor cap or cap and rotor kit installed, if those components were purchased by the dealer between the dates of January 1, 2011, and May 24, 2011, and if they use brass conductors. The consumers will need to have the distributor cap replaced with the new service part.

- MerCruiser serial number
- Flat rate codes and labor:

  - MI20–0.5 hr
