Scope

Worldwide

Situation

Mercury Diesel has identified a situation with the Ultraflex Mark I electronic control system that was installed on the above mentioned engines. An electrical short inside the wire harness of the system may cause incorrect throttle position sensor data and unintended engine acceleration. This failure may result in a loss of throttle control for the vessel.

Mercury Diesel has also identified a situation whereby the oil supply line to the turbocharger could loosen. This issue has the potential to affect all engines, regardless of engine run time or engine service history. Loosening of the oil supply line can allow engine oil to leak onto hot engine components and can cause an odor, smoke, or, in rare cases, a fire.

Inspection

Determine which type of control system is present on the vessel. Vessels with engines that are currently controlled with an Ultraflex Mark I system will need the system updated to an Ultraflex Mark II. If the vessel is already equipped with an Ultraflex Mark II system, no further action with the control system is required.

Engines that have the oil sealing washers reworked by the factory or by an authorized dealer will have a mark indicating that the rework has been performed. With the engine removed from the shipping container, or installed in a boat, the rework identification will be a yellow dot placed to the left of the serial number decal.

Correction

Control System

Remove all of the existing components of the Ultraflex Mark I control system and replace it with the new Ultraflex Mark II system. Installation and programming instructions are included with the Ultraflex kit.

Oil Supply Line Sealing Washers

- 1. Remove the engine cover.
- 2. Remove the hollow bolt securing the oil supply line to the turbocharger.


Oil supply line hollow bolt

3. Remove the sealing washers on each side of the hollow bolt fitting.

4. Install new sealing washers and tighten the hollow bolt finger-tight.



5. Tighten the hollow bolt to the specified torque.

OFFICIAL NOTIFICATION OF FEDERAL BOAT SAFETY ACT RECALL

Dear Customer,

Thank you for the purchase of your Volkswagen Marine power package. Mercury Marine, is authorized to distribute and service Volkswagen marine engines and is dedicated to providing superior products and customer satisfaction for all of your boating needs. Through our collaborative efforts with Volkswagen Powersystems, we have determined that your power package must be recalled so that we may perform updates required to ensure the safe and reliable use of your power package.

What is the condition?

We have identified a potential issue with Ultraflex control system on your vessel. You may notice an unintended acceleration, most perceptible in the event of a fault in the throttle position sensor. If left unattended, this issue could possibly lead to a loss of throttle control of the engine. Do not operate the boat until this situation has been corrected. Along with replacement of the Ultraflex control system the sealing washers on the turbocharger oil supply line will also be replaced.

What will Mercury Marine do?

We have provided instructions to our dealers on the updates to be performed to your power package.

What should you do?

Please contact your authorized Mercury Diesel servicing dealer and mention this letter regarding necessary updates to your power package. Also mention Mercury Diesel Service Bulletin 2017-63 and schedule an appointment to have the updates performed. Your servicing dealer will be able to determine how long the repair will take. This update will be performed at no charge to you.
